Hospitality SMEs who prioritise the procurement of eco-friendly and sustainably sourced products can minimise environmental impact and support the circular economy. This approach aligns with the Public Procurement Directive (2014/24/EU), which encourages the use of green public procurement criteria.



Examples:

Cleaning Supplies: Choose biodegradable and non-toxic cleaning products to reduce the release of harmful chemicals into the environment.

Toiletries: Provide guests with eco-friendly toiletries, such as shampoo and soap bars made from natural ingredients and packaged in recyclable or compostable materials.

Local Sourcing

Sourcing food and products locally is crucial for reducing transportation emissions and supporting the local economy. This practice is in line with the principles of the **Common Agricultural Policy** (CAP), which promotes sustainable agricultural practices and rural development.

CREATING LOW-COST SUSTAINABLE TOURISM OPTIONS

Many destinations aim to attract high-spending, sustainability-conscious travelers, leaving low-budget tourists with fewer sustainable options. This approach limits the equitable distribution of tourism benefits.

Local authorities and tourism organisations should partner with small and medium-sized hospitality businesses to establish affordable, sustainable tourism options. This includes organising meetings, providing assistance with sustainable practices, and guiding on funding opportunities to enhance innovative and budget-friendly travel experiences for all tourists.
